**BUILDING PERMIT APPLICATION**

- Application must be fully completed
- Must be signed by owner or submitted with a letter of agency

**SITE PLAN**

- North arrow
- Lot dimensions--all sides
- Size and location of any easements or right-of-ways
- Names and locations of all adjacent streets
- Locations of proposed and existing structures
- Setback dimensions--front, rear, and all sides
- Outside building dimensions and distances between buildings on building site
- Driveways, exterior stairs, landings, patios, and decks
- Location, type, and elevation of any retaining walls

**BUILDING PLANS (two complete sets required)**

- Complete set of house plans from modular company. Plans must have approval stamp from NYS Department of State. All options selected must be indicated and any options not selected must be voided. Plan must clearly indicate requirements for connections required between house and foundation, house modules and roof installation.
- Plans for foundation and any other construction built on site. (decks, porches, garages, etc.)
- Window well dimensions for emergency escape windows below grade
- Stairway landings, rise, run and handrail for stairs built on site.
- Guardrail height and pattern

- \_\_\_ Building elevations with finish grade line on all sides(exterior views)
- \_\_\_ Typical footing size, depth, and reinforcement
- \_\_\_ Foundation wall height, thickness, and reinforcement
- \_\_\_ Foundation sill and anchor bolts

**PLUMBING DETAILS (a separate plumbing permit will be required)**

- \_\_\_ Location of all plumbing fixtures including layout for future fixtures
- \_\_\_ Floor drains, water heater, clothes washer and dryer locations

**MECHANICAL DETAILS (a separate heating permit will be required)**
