Amend Town Code, Chapter 203, Entitled "Water", Specifically Section 203-5 Entitled "Connection With Mains"; Section 203-8 Entitled "Rate, Charges and Billing" and Section 203-6 Entitled "Meters: Civil Penalties"

RESOLUTION

BE IT ENACTED, that the Town Board of the Town of Poughkeepsie pursuant to a public hearing held the 18th day of November, 2009 at 7:00 PM at the Town Hall, Town of Poughkeepsie, One Overocker Road, Poughkeepsie, NY does hereby amend the Town of Poughkeepsie Code, specifically Chapter 203, entitled "Water", which amendment would be as follows:

Section 203-5-Connection with Mains

I. DELETE:

Section 203-5 (A)(3)- "Buildings requiring fire line services must have a separate domestic water service. Combination fire and domestic water services are not permitted."

- II. AMEND (new material in bold print):
 - E. Copper Type K is the only acceptable pipe for service laterals up to 2" and under 200' long. Services 1" and up to 2" over 200' long that require a meter pit may be installed using 200 psi PE (Polyethylene) plastic pipe between the meter pit and the house. Type K Copper must be used from main to curb box and curb box to pit. The CTS (Copper Tubing Size) Poly pipe connects using stainless steel sleeves and compression fittings. Plastic pipe must have 5' of cover and be installed with a tracer wire for locating purposes. Services larger than 2" must be ductile iron pipe. Fittings must be compression type for copper pipe. Non-draining curb boxes only.
- III. AMEND (new material in bold print):

Section 203-8-Rate, charges and billings.

- D. Tap charges
- (1) The charge for taps of 3/4" and 1" size shall be increased to \$150 from \$55 and increased to \$185 from \$65, respectively. Materials to be supplied by others.
- (2) The charge for taps from 1 ¼" to 2" size shall be \$275. Materials to be supplied by others.
- (3) The fee of \$750 for a standard large tap, and \$950 for 20" or larger tap shall be charged. Material to be supplied by others.
- IV. AMEND (new material in bold print):

Section 203-6-Meters, civil penalties.

C. Change penalty from \$75 to \$150.

Jim Beretta: The Planning Budget is going up \$52,517 from \$446,994 to \$499,511 and I was curious what that increase was. It looks like salaries and part time is going up \$46,000.

Councilman Baisley: Yes, that's two girls that were Section 8 that had to be moved over because of no more Federal funding. They moved them from Section 8 to Planning Department.

Neil Wilson: Yes, we had been notified of changes in the Section 8 funding for those positions based upon participation within the Section 8 program. Effectively, those two part-time positions, which had been funded through Section 8, were no longer going to be funded through Section 8 as a result of that.

Jim Beretta: The other question I had was on the traffic control. It was going up from \$5,000 To \$29,400.

Councilman Baisley: Yes, that was for street striping and extra street light maintenance for some of the control boxes.

Jim Beretta: Also, on the agenda, I was curious about the Police Department, is that for cars? Are they switching to LED lights from the old style or what? (Yes)

Doreen Tignanelli: My concern is with the contracting services on the Town Budget. We are spending an awful lot of money for contracted services for legal and engineering and I don't know if that is going to be reduced but we had estimated \$95,000 for contracted legal services for 2009. As of today, we've spent \$232,000. Now, I've been at a lot of Board Town Meetings where you've talked about hiring special Counsel and there is no ceiling on how much is to be spent for hiring. For example, Richard Cantor July 1, 2009 at a rate of \$175 an hour to represent the Town in a legal action against the Dutchess County Resource Recovery Agency, but it didn't say what the maximum amount was. I know in the past we used to do that. Are we paying enough attention to contracted services? Again, that is in addition to the Town Attorney's salary. As of today we've spent \$232,000. Engineering services also. The budgeted amount is \$132,940 for 2010 and that is in addition to the Town Engineer's Salary and so those are two areas I would like to see reduced if possible and also we need more accountability. I would like to see resolutions include description of services, the hourly rate for services and the maximum amount for the expense before voting on the resolution and additionally line items should be consulted to see if over budget conditions exist or will occur. Legal has gotten way out of control.

Michael Schnorr, Chairman of Plumbing Board: We have specified clearly what the home owner is allowed to do without a permit. We have eliminated the fee that the Town now had before the homeowner could take a test to get a permit to do major work on his home and as addressed at the last meeting, part of this amendment was to eliminate the homeowner from doing any outside, underground, Town water and sewer work, which the Water and Sewer Department really feels should be left to the professionals.

BE IT RESOLVED, that the Town Board of the Town of Poughkeepsie does hereby set the {9th} day of December, 2009 at 7:00 PM at the Town Hall, Town of Poughkeepsie, One Overocker Road, Poughkeepsie, NY as and for the time, date and place of a public hearing to consider an amendment to the Town of Poughkeepsie Plumbing Code, Section 154-31, entitled "Homeowner's Plumbing Permit", which amendment would be as follows:

AMEND (new material is in bold print):

Section 154-31. Homeowner's plumbing permit.

The administrative authority is authorized to prepare and administer an examination for any homeowner who seeks a plumbing permit to perform work within the dwelling on his or her own property under the circumstances as described in Section 154-4 of the Town Code, which established the need for the permit. The purpose of the examination is to enable the administrative authority to assess the capability of the individual to deter abuse of this privilege. The terms of this provision are applicable only to residential properties owned and occupied as the homeowner's principal residence and shall not be construed or interpreted as authorizing any work by a non-licensed plumber between the water main and the house and such activity is expressly prohibited.

ADD:

In precedence over any other sections or provisions of Town Code, the Town Board duly recognizes a homeowner's right to make basic indoor plumbing repairs (as noted below) without requirement of payment of fees of any kind, and without requirement to obtain Town permit or any kind, within premises such homeowner owns and occupies.

{"Basic indoor plumbing repairs" include: replacement of, and/or replacement or repair of components of, showers, bathtubs, toilets, sinks, drains, faucets and associated piping, within 12" of the fixture."}

AND BE IT FURTHER RESOLVED, that the Town Board of the Town of Poughkeepsie does hereby declare itself as Lead Agency, does determine that this is a Type II Action, and does further determine that no further environmental action is required; and

BE IT FURTHER RESOLVED, that said local law, upon adoption, will become Effective upon filing with the Secretary of State as prescribed by law.

Councilman Tancredi: Now, the part where you read, "Basic indoor plumbing, and repairs include..." Those are things the homeowner can do right now?

Councilman Cifone: Correct.

Councilman Seminara: I would just like to advise Councilman Cifone and the Plumbing Board that this was the concern I had that we weren't clear and I believe now that all those repairs you can do without fee and without permit, those basic indoor plumbing repairs, yet, with the

suggestion of the Plumbing Board, we still protect that you are not allowed to just totally rearrange fixture and put them from one place to another, and that you would have to come in and take a test for those more advanced things, and the guys did a great job and I want to acknowledge that and thank you very much for sticking up for the homeowner and finding that balance where we should say, "Maybe we need to talk to you a little bit".

Supervisor Myers: So far, the activity has been \$88,000.00 for Building Permits and \$165,000 for commercial. We already have \$150 and \$250 budgeted. You are suggesting that we increase both of them by \$15,000. We are not even going to come close to what we have budgeted for next year, this year. I would love to see it happen and love to see us reach those revenues, but it will impact the taxpayers next year if we don't come close.

Councilman Seminara: Guessing in the other direction impacts the taxpayers, too, although it's a pleasant surprise. You are talking about two estimates here that vary about 10% from each other and I think there is later information that we are dealing on to get that estimate. I don't have a problem trying it, because I trust your judgment and Tim Sickle's judgment.

Supervisor Myers: I would say the same thing here, particularly when it comes to the Planning Fees. The Budget for next year is \$100,000.00 and so far this year we've taken in \$38,000.00 and you want to raise that projected income.

Neil Wilson: Yes, Again, one of the things we are working on is that simply increases in regular fees, the application fees, but we are also preparing, for your consideration, we will have this up for the December 2nd meeting, revisions to Chapter 105 FEES, to also include additional fees for, say, an applicant who has received an approval and goes out and builds something other than what he had received an approval for. That always raises issues of enforcement and the need,

often times, for a subsequent amended approval by the Planning Board. So, the second time around is a result of the enforcement, in other words, the reconsideration of an amended plan because he didn't build it right the first time. That would be subject to essentially doubling the application fee. The other thing we are working on is Chapter 106 that is referred to right now as the Escrow of our Code. The Escrow, the way they are set up now, we collect the Escrow fees for payment to outside consultants, Engineering, Legal, Wetland Consultants or whatever needed to be. It seems to be altogether reasonable to also allow for staff, Planning Staff, Zoning Staff and Building Department Staff during the review of those applications that come before the Planning and Zoning Boards. We also tap into those fees as part of the review. We do not entirely cover all of the review costs to the Town, in other words my time, my planner's time and my Zoning Administrator's time, Building Department's time reviewing applications coming into the Planning Board. If we are charging an application fee for a Site Plan, that fee only covers part of total staff, which also includes clerk, processing, and placement of newspaper notices of public hearings. Also, some of the larger projects take more staff time than others. So, one of the thoughts is to amend Chapter 106 to allow for the actual cost of staff time to be charged as the outside consultants do for their hourly rates to review matters to be sent out to, say, Engineering for their review. Town staff would then have the ability to charge their time against those Escrow fees. That's what you are seeing here and this is a very conservative estimate because I do believe that ultimately people seeking approvals should also pay the cost of the Town's review. So what you see here is the Planning and Zoning fees being increased to represent that. The Planning Department took in considerably more in 2008 and early 2009 than it has more recently, which is why the fees you see here are actually 20% of the totals coming in and maybe a little bit less and so I think they are very conservative. It's a cost allocation program is what I'm describing where you have Town staff charging their time against the Escrows that are paid by applicants as opposed to simply using those Escrow fees to pay for outside consultants.

Councilman Seminara: I think that's a great idea. That's probably something that hasn't been done in many municipalities for a long time and I am very happy with your analysis you have provided for us, thank you. I would certainly support that to a pretty high level, however, I do feel that some of the people who are using those services may be Town residents or Town business people that pay taxes and deserve some services.

Councilman Seminara: In our infrastructure Committee meeting that we hold, we have about, because we were able to come up with a lot of efficiencies in the last set of rolls we did and probably because the economy was a little bit bad and things came in at better prices, we have about a million of road funds left. The three projects on the Federal Aid, which you know I don't like any way, are in it, and come in at \$4 million dollars, but they don't pay for it up front and I was advised today that we would expect payment within a month, but it hasn't been forth coming. We might get payment in three or four months. We don't really have enough money since we have fortunately a million dollars in bond money left, because we got lucky and did a good job with the last bond. We had about a million available, but we have about four million dollar projects we have to pay for up front and it has taken as long as three months and we still don't have a check yet and we don't have a firm date of when we are getting this money back. We have a potential problem here. The potential solution, is if the Board decides to do another road bond, you can kind of use that and borrow from the savings account and put it back when you get the check. But, we don't have it right now and we don't have a bond out there right now, so, it's something that I didn't not want to bring to your attention that you have this floating out there.

Councilman Baisley: (Inaudible) from the Federal Government?

Supervisor Myers: You mail in your bills as you get them, yes.

Councilman Seminara: There is an additional complication. They changed the requirements. I think it's through DOT that they require that you must start these projects by March 15th on top of everything else. So, that's as much information as I have.

Supervisor Myers: You have three years to do the paving, you would have to start submitting a bill by March 15th, but you are billed for advertising for the bid and preparing the bid documents.

Councilman Seminara: No, I believe you are wrong and we have a little bit of a problem here. You are taking a risk and the only way you can cover the risk is to already start thinking about your next road bond.

Councilman Cifone: We can certainly take that into consideration, but going to bid could be a start and we could get a check in from one of the other roads. We are waiting on checks to come back in now.

Doreen Tignanelli: In addition to having the Police Chief check on this for Matthew's Mug, and I don't know if this is part of his review, but, how about checking with the Arlington Fire District for the EMS calls because I just read an article in the Vassar Misc. News where they talked about the record number of kids transported to area hospitals over the Halloween weekend and it was a pretty high amount and of course that is something that all taxpayers in the Arlington District are paying for in addition to, also, police fees if the police need to respond. I, also, would like to thank the board for over the last month or so for the budget process. I've been complaining also that the Town residents should not have to pay for repeat violators as part of the Planning Board process and I mentioned the Van Guard Site and Ciffdale Site and I'm glad to see that that is being addressed, so thank you.

Jim Kitcher: I'm here again to kind of update the Board on the status of what is going on with the Germano property improvements. Neil Wilson is working on an agreement and he is getting closer, but as far as I can see, nothing has changed, not one thing, from two months ago, four months ago or three years ago. The Town has allowed again, him to seize this property, use it willfully the way he wants, disrupt part of our lives on our block and it hasn't cost him one nickel, hasn't cost him one hour of his business being down and again, along the lines you were saying before, if he had to pay us and you for all the time we had to spend about it, he would owe us a lot of money. My whole point here is that right now, Neil has an agreement that he is going to try and extend this fence this year and wait and do all the landscaping next year. Nothing is being said about this whole border and where the fence is going to be. My suggestion is that the Town put curbing or ask him to move the curbing so that this line which defines where the new fence will be and direct the traffic into the site so he can't park cars all in this area, and be put up NOW, like this WEEK, so he can't park cars over in this zone, while we are waiting for the fence to be put up. He should be restricted from using that property starting NOW. I am happy with the way we are going with this, I just hope we get there within my life time.

Jim Baretta: I just want to talk about the Woods at Cliffdale, the former Girl Scout property. I think everyone knows that there were a set of pillars that were starting to be constructed there that were not on the plans. The very first bricks and mortar that showed up on that planned site were not even on the plans. Anyway, they got a STOP WORK ORDER on that and so they were in here last Thursday night at the Planning Board Meeting and it was called an amendment to a private road or something like that, but I was disappointed that nobody in that meeting said that there was a STOP WORK ORDER. The whole conversation took place like it was some amendment. I am pleased that I was given a chance to talk because residents were not give the opportunity to talk at Planning Board Meetings before unless it was a hearing. The bad part though, is we weren't given a chance to talk until at the end of the meeting and so by then the discussion and vote had already taken place. It was an improvement that the residents could talk about it, but it happened after the fact, so there was a plus and a minus there. They were given conditional approval on the pillars with a 7-0 vote. Also, one of the pillars was being built in a rain garden and so one of the conditions was that they had to relocate the rain garden. They had to do some map notes and the Chairman had to sign the plans. Well, the next morning at 9 AM, they were working on the pillars. Neil went out to the site and told them to stop work because the STOP ORDER was still in affect. The applicant here is really making it difficult for everybody. There is a huge list of items here.
