Jim Beretta: Regarding SC 6 and SC 7 – How long is appointment for?

Supervisor Myers: 7 years.

Jim Beretta: Feels 7 years is a long time for appointment. Pointed out that the Zoning Board was chastised by the Dutchess County Planning for giving out Sign variances until it could be controlled. At the next Zoning Board Meeting, the Zoning Board gave sign variances and feels James Santoro has ignored the chastisement of the County to stop giving sign variances and now that he is up for re-election as Chairman, he is on "Good behavior" when he expressed to someone at a meeting who wanted a sign permit, that we have been, over the years, trying to better enforce what our Town Code says. That's Jim Beretta's observation. He also talked about Richard Davison appointment. He is up for seven years appointment and he is a very influential person on the Board. He rarely misses a meeting and always seems to be prepared. But, my opinion is that, everything

on Route 9 is a reflection of the philosophy of Richard Davison. There are Planning Board members here that come and are ill-prepared, late and go to Florida for the winter and Richard Davison always gets the applicants to get to the point when presenting their application. He would be a great guy for rubber stamping things and pushing process through, but the Planning Board needs a philosophy and a vision, you can't just push people through. I have never seen him or any other Planning Board Members even talk about the Bio-Diversity study since it has been up. The Girl-Scout property, when it got its final approval at the last meeting, there was a debate and it was said that that the people doing the archeology study were not qualified to do it. "After the hearing, Richard Davison looked directly at me and the people here with me, and said, 'Maybe we should take all of those existing houses and knock them down and search for artifacts.'" These are neighborhoods that have been there 30 and 40 years. "My opinion on Davison is the same as it was on Santoro, a yes vote for them, I personally do not approve of it."

Bob Casement: I'm here regarding the dedication of the Arlington Hunt roads. He is still having trouble with the water coming down from their property on to his. No one has contacted him from here since he was here last regarding this subject.

Supervisor Myers: It is part of the agenda resolution, specifically mentioning your property.

Town Attorney Mahar: You have representatives here from Toll, also.

Bob Casement: The resolution does not resolve my property. That's like having a hole in your roof and water coming in and someone telling you you need a drain in the middle of your kitchen to let the water out. That doesn't solve the water coming off the hill. Not happy with the resolution offered in the resolution.

Doreen Tignanelli: SC 4. Have all of those problems been solved? Councilman Baisley, I don't see approving it.

Supervisor Myers: We have no backup documentation on it.

Town Attorney Mahar: You realize, the maintenance bond was put up over 18 months ago in regard to when we accepted Alex Way, which is the road. Before bringing the action to the Board, I contacted all the department heads and they all signed off on the release of the maintenance bond and I'm not aware of any other problem.

Virginia Buechele: She agreed with Mr. Beratta's statements in regard to Chairman Santoro and Vice-Chairman Davison.

Town Attorney Mahar: Mr. Davison has been on the Board since January 1, 1995.

Virginia Buechele: That's way too long, thinks the law should be changed. Item 22. I would like to confirm that that is at no expense to the taxpayer. Who will be manning that and will the Town be paying those salaries or will the salaries be paid by Marist?

Councilman Baisley: That is a substation for the Police Department, it's for the Town of Poughkeepsie, not for Marist College. It's so he can get his patrols out to cover that end of the Town of Poughkeepsie. No expense to the Town.

Nancy Zverev: (Inaudible) I really don't think a lot of the people are for Bright Horizons. The time is not right for us to be expanding our government.
