Supervisor Myers made the following announcements:

- Supervisor Myers congratulated the P.B.A. on their grant received for the Selective Traffic Enforcement Program, which amounted to \$10,500 for patrols and \$1,752 for equipment.
- Beginning April 4, 2009 and continuing for twelve weeks, census takers will be entering neighborhoods to verify addresses of residents.
- On March 28, 2009, an international EARTH HOUR has been declared to bring awareness of the climate change. To participate, all citizens are asked to turn off all unnecessary lighting between 8:30 PM and 9:30 PM. In America, many famous cities and landmarks such as those located in areas of Washington, D.C., New York City, the Golden Gate Bridge, Los Vegas strip and Niagara Falls will turn off all lights during that time period. Over 1,500 cities are participating.

### RESOLUTION

BE IT ENACTED, that the Town Board of the Town of Poughkeepsie, pursuant to a public hearing held on the 18<sup>th</sup> day of march, 2009 at 7:00 PM at the Town Hall, Town of Poughkeepsie, One Overocker Road, Poughkeepsie, NY, does hereby amend Chapter 57, entitled "Animals", specifically Section 57-2, "Unlawful Acts" and Section 57-5, "Enforcement", which amendments would add the following provision:

ADD to Section 57-2:

F. Nuisances prohibited. No person owning, harboring, keeping or in charge of any dog shall cause, suffer or allow such dog to soil, defile, defecate or commit any nuisance on any common thoroughfare, sidewalk, passageway, bypath, play area, park or any place where people congregate or walk, or on any public property whatsoever, or on any private property. The restriction in this section shall not apply to that portion of the street lying between the curb lines, which shall be used to curb dog under the following conditions:

- (1) The person who so curbs such dog shall immediately remove, in a sanitary method, all feces deposited by such dog.
  - (2) The feces removed from the aforementioned designated areas shall Be disposed of in a sanitary manner by the person owning, harboring, and keeping or in charge of any dog curbed in accordance with the provisions of this Chapter.
- And

ADD to Section 57-5:

The provisions of paragraph F of Section 57-2 shall be enforced by the Town of Poughkeepsie Animal Control Officer.

AND BE IT FURTHER ENACTED, that the Town Board of the Town of Poughkeepsie does hereby declare itself to be Lead Agency under the New York State Environmental Quality Review Act and does declare that said action is a Type II Action;  
And

BE IT FURTHER ENACTED, that said local law shall take effect immediately upon filing with the Secretary of State.

Councilman Baisley: Is private property a part of this?

Town Attorney Mahar: Yes, "to be a nuisance on private property".

Councilman Baisley: It's our call and not the Department of Health's call?

Town Attorney Mahar: We have simultaneous jurisdiction with the Health Department on it.

Councilman Seminara: I observed, basically what we are saying is the dog has to defecate in the street and then has to be removed, which I don't have any problem with the removal part, but sometimes it defecates in the grass and remove it. I don't go along with the "curb to curb" part of it. Councilman Tancredi agreed. He felt it was

unrealistic to make the dog go in the road. He thought the point of the resolution was simply to pick it up afterwards. Councilmen felt the resolution needed to be rephrased.

Councilman Seminara: So this is the NYS Building Code?

Wayne Cichon: Yes.

Councilman Seminara: How much do you estimate these books cost?

Wayne Cichon: Currently they are like \$495 per set.

Councilman Seminara: How many sets would the Town need, just the Town?

Wayne Cichon: One per Code Official. We have 8 Code Officials in the Town. So we are looking at \$4,160.00. It's a three year process.

The Board felt that the State is asking the Town's to enforce their Building Codes and so they should provide the Code Books to the officials and not push the cost on us.

6 Maisie Court For Outstanding  
Water Charge

#### RESOLUTION

WHEREAS, the Town Board of the Town of Poughkeepsie is authorized pursuant to the Town Law, Section 198 (3)(d) to provide by resolution that unpaid water charges in arrears for thirty (30) days or long shall be subject to a penalty not exceeding ten percent (10%) of the amount due; and

WHEREAS, the Town Board of the Town of Poughkeepsie is also authorized pursuant to Town Law Section 198 (3)(d) and Section 89b of the Public Service Law to discontinue the water supply if such water charges are not paid within sixty (60) days from the date due; and

WHEREAS, the Town Board of the Town of Poughkeepsie has adopted Section 203-8 F of the Town Code of the Town of Poughkeepsie, which reads as follows:

“If all such water rents, charges and penalties shall not be paid within sixty (60) days after the date due, the Town Clerk shall mail to the owner, or if previously directed to send bills, notices, etc., to an agent or tenants, then to such agent or tenant, a notice of arrearage, containing the total amount then due with notice that, unless paid within five (5) days after date of mailing such notice, service will be discontinued unless such bill and the whole thereof shall be paid within said five (5) days or the next business day after the expiration of said five-day period, and such service shall not be restored until all charges and penalties shall have been paid and the further sum of twenty dollars (\$20.00) shall have been paid for the restoration of service.”

AND WHEREAS, the owner of 6 Maisie Court, Poughkeepsie, New York was notified on the December 3, 2009 and January 20, 2009 of an outstanding water charge for said premises; and

WHEREAS, a payment dated February 17, 2009 was tendered but rejected since it did not constitute the full amount due or admit liability for the balance due; and

WHEREAS, of March 18, 2009 the owner has not paid said bill, now therefore

BE IT RESOLVED, pursuant to Section 198 (3)(d) of the Town Law, Section 89b of the Public Service Law and Section 203-8 F of the Town Code of the Town of Poughkeepsie, entitled "Water", said service will be discontinued as of the 20<sup>th</sup> day of May, 2009; and

Councilman Baisley: After last week’s meeting in reference to this item, the residents offered up about 7 or 8 houses as potential sites to establish a group home. A couple of the houses were definitely out of the Town of Poughkeepsie. One house on Vassar Road, but there is one already on Vassar Road. Round Hill was offered as a site, but there is one on Creek Bend which is just around the Corner from Round Hill from the back, so that one is not feasible either and they came up with three other ones today. One was One Marwood Drive, which is a rather large ranch. One on 39 Nassau Road, a raised ranch and the other was on 118 Kingwood Park and one on Scenic Drive, which was very expensive and none of these were in my Ward. (Humming made it very difficult to understand Councilman Baisley)

Councilman Seminara: There is approximately, in excess, 170 homes in Dutchess County and about 20 or so in the Town of Poughkeepsie, which are scattered pretty evenly throughout the Town and so I don’t think there is any case to be made.

Town Attorney Mahar: (Inaudible)

Councilman Baisley is going to call John and discuss this further with him.

Virginia Buechele spoke about how this Board passed a nine month moratorium on residential development in the Industrial Zone, which appeared to her would expire on April 9<sup>th</sup>, 2009 and she said if she was recalling correctly, in that original resolution it talked about one of the reasons that you were doing this moratorium was so that there

could be a build-out analysis. She wondered if that build-out analysis was done and why she doesn't see anything on the agenda to renew the moratorium for another nine months.

Virginia Buechele: When was that that he addressed you?

Town Attorney Mahar: I believe it was in an In-House Report.

Virginia Buechele: Is that In-House Report FOILable? I would also like to know "How Costly was Too Costly and just what his analysis was? I think it's an important issue in our community.

Town Attorney Mahar: I don't think it is.

Victor Gennodi talked about a neighbor having 5 dogs at their house and they have a spot that the dogs go which is right next to the people's swimming pool and there is always a fight because the odor is terrible, hopefully this law will have some teeth for these people. About the first public hearing you had, how is this going to be enforced. Are there fines?

Town Attorney Mahar (Inaudible)

Victor Gennodi: Ok, so there will be fines. What are the time frames?

Supervisor Myers: 10 PM to 5 AM Prohibited.

Victor Gennodi: 5 AM in the morning having 40 trailers coming by your home, your house becomes like a heavy thunderstorm when each truck goes by. I would have been a lot happier with 6 AM.

Nancy Kverev : #23 – 72% recreational and 28 % IBM Conference Center. Is this partially paid from the Recreational Funds for the Casperkill due-diligents?

Councilman Seminara: Point of order – this is not an IBM Conference Center. We are considering purchasing this from Bright Horizons.

Supervisor Myers: Yes, it is Nancy.

Nancy Kverev: Right, it just appears to me it was not accurately shown on the memo here, on the web. Then a couple weeks ago, going over the Greenvale and getting \$90,000 or for their creek erosion out of the Recreation fund, can I just ask, what are the criteria?

Councilman Seminara: It was \$20,000.

Supervisor Myers: It has to be a capitol improvement, it can't be for basic repair, like playground dirt or something like that. It could be playground equipment. He has done a very good job in trying to space out a lot of playground equipment. He tried to share it equally through out the Wards when they need the money. It is thought out and tried to be divided up fairly.

Nancy Kverev: Also, concerning the Rochdale petitions, when Councilman Conte comes up with whatever you are going to do, if something is on those petitions, can I know if things could be done in a volunteer method?

Supervisor Myers: Ok course, we'll let you know. It would need Town Board approval, but, yes, volunteers are welcome.

Doreen Tignanelli: I would like to ask the Town Board to take up the issue of the tree ordinance again. The site next to Raia Self Storage on Route 9.
