Supervisor Myers: I have one question. In Section 12, why are we saying "May" instead of "Shall"? Last page, Paragraph 8 of the Agreement.

Dave Wise: It leaves in the Chief's discretion, whether or not to pursue discipline, if it's mandatory. For example, prohibition under this provision, would be taking a prescribed substance for someone who does not have a prescription. In many instances, like if one spouse has a prescription for a certain anti-inflammatory or a pain killer and the second spouse has a different prescription and the second spouse being an officer, that prescription runs out and the officer decides to take some of the spouses anti-inflammatory or pain killer, under this provision, that would be a violation of that contract, but under that circumstance, if the Town Board must pursue discipline, under those circumstances, you might not want to do it. So, this really gives the Town discretion to work with an officer when there might be a extenuating circumstances.

Councilman Cifone: We are working on it, though. We should hopefully very soon have it worked out.

Doreen Tignanelli: Is the Technology Committee making progress on the audio? I saw the Town Clerk asking people if they could hear Councilman Cifone. Are we making progress moving forward?

Councilman Eagleton: Not yet. That's mine. Not yet.

Supervisor Myers: Mark is working on that. He has gotten stuff from Hugh's TV and he's putting that together to go out and get other quotes.

Doreen Tignanelli: The meeting with the DOT and Assemblyman Miller's Office, Councilman Tancredi told me it is scheduled for this Friday, is that still the case?

Councilman Tancredi: Yes. Getting all people involved together has been the delay.

Doreen Tignanelli: My last question, the water from my home and I was told that they are looking for a long term solution to the problem and we are still having problems. They are still doing the flushing once or twice a week and they ended up doing that all through the winter. I asked the Chief how much water we used in the flushing, so far, just from May of 2009 to March of 2010, we've used over 3 million, 103 thousand of treated water and we are still having the situation with the brown water. So, we need a long term solution to this problem and it's been well over a year since it happened.

The Town has been working on it. The City also has the same problem at one location and it has not been a simple problem, but they are continuing to work on it to make those changes that will eliminate the problem. It's not an easy process.
