Supervisor Myers: Before I suspend the rules for agenda items, we will have the next item on the agenda, which is a presentation from Recreation Director Tom Meyering.

Recreation Director Tom Meyering gave a video presentation of "The New ADA" (Americans With Disabilities) Parks Compliance Plan. The Town is required to adopt a "Program Access Test" by March 15, 2011. This is a tool to evaluate whether "Facilities" are available to all (Including Disabled) and spread throughout the Town. Also, the Town is required to make physical upgrades from the "Program Access Test" to existing facilities by March 15, 2012. Mr. Meyering discussed the key issues for the Town and work needed for designated "Facilities" and the rough cost estimate for the work is \$78,900.00. This directive came to him through the New York State Recreation Park Society and the National Recreational Park Society.

Councilman Tancredi: This would be eligible for Community Block Grant money wouldn't it?

Director Meyering: I think, depending upon where it is.

Supervisor Myers: I don't think you can split it up because not enough of these places we've chosen would qualify. I can only think of one park that would qualify, which is Fairview Park.

Director Meyering: I believe that the Community Development Block Grant is being slated by the current Congress to dispose of it.

Doreen Tignanelli: I have a question about agenda item # 11 to amend the Town Zoning Code for Flag Lots. The Flag Lots was amended, I believe, when the master plan was updated in 2006 – 2007 time frames. I was wondering what the change was.

Development Director Neil Wilson: The Zoning Code expressly prohibits the creation and establishment of flag lots and typically the way the prohibition works is by establishing a minimal frontage requirement at the street line and a minimum lot width at the building line. Typically those two numbers should be the same so you end up with a lot that if you need 100 feet of frontage and 100 feet lot width at the building line, you end up with a lot uniformly square and the idea is, you don't have a flag lot, but a series of lots that are intended to be established and built upon. One of the thing my staff has been continuously doing is taking a look at the Code language and we've been presenting to the Board various amendments and cleaning them up and this happens to be one of them. The area and bulk requirements for the residential lots and for the commercial districts, you will see, in some cases, a standard for frontage, which is at the street line, but you will not see it in others. It was an oversight in drafting the original Code. So, the proposed language is to give full effect and clean up and provide for the appropriate lot frontage and lot width standards for all the districts.

Doreen Tignanelli: Does this have anything to do with the Flynn sub-division flag lot?

Neil Wilson: Not specifically, no. This is a necessary fix, in any event.

Jean Murphy, Town Historian: I am speaking to the appointment of Robert Rubin to the Historic Preservation Commission. I was first appointed as Assistant Historian in 1990 and we applied to be a certified local government with the State and I went to a meeting some years after that and they never filed it and then she sent a letter saying they did file it and they got in 1995 filed. But, because we have it, I was able to get from the State museum a copy of the Town Charter. When we read it, we found out that they had left out the Town of Fishkill and I questioned that and they sent me several pages for \$10 and one more page for \$10. That's their minimum. Robert Rubin would be an excellent member to our Historic Preservation Commission. He is really interested in the Town and he is very knowledgeable and we really need him. We still need someone to represent the Fourth and Fifth Wards.

WHEREAS, the action to amend the area and lot requirements for the various zoning districts in order to properly regulate the establishment and creation of flag lots is a Type I Action under the New York State Environmental Quality Review Act ("SEQRA"); and

WHEREAS, the Town Board has determined that the proposed amendments must be referred to the Dutchess County Department of Planning and Economic Development and to the Town Planning Board for review and recommendation; and

WHEREAS, the amendments are subject to a public hearing.

NOW THEREFORE BE IT RESOLVED THAT:

1. The Town Board hereby sets a public hearing on the proposed amendments to Chapter 210, which are attached as Exhibit "A", for March 23, 2011, at 7:00 PM, or as soon thereafter as the matter may come to be heard, in the Town Hall, One Overocker Road, Poughkeepsie, New York; and

Doreen Tignanelli: I just wanted to follow up on some items from last Town Board Meeting. I brought to the Board's attention that Supervisor Hickman in East Fishkill had substantial savings on road salt through due to the fact that they had equipped some of their trucks computers and Temperature apparatus and Councilman Cifone asked how many trucks they had and I did check and he said that they had 20 trucks and they changed all of their trucks that had hydraulic spreader controls and he said it saved them a significant amount of money. Someone also asked about Grant money and he said that he was not aware if there was grant money for that and they used their own money, but the investment paid for itself in the first year. They had substantial savings. I also talked last week about Vassar College and the fact that their party had cost taxpayers in EMS calls and I directly e-mailed college officials asking them if they would hire an ambulance for their TOGA party last weekend and the day before the party I did receive a

response from one of the Deans of the college saying that they had hired an ambulance service for both Friday and Saturday night from 10 to 2 which would alleviate the burden on the taxpayers in the district and I also asked him to consider every Friday and Saturday night during the school year to hire a private ambulance and that would come out to approximately \$48,000.

Supervisor Myers and Board all thanked Doreen for her efforts in that achievement.

Robert Rubin: Thanked the Jean Murphy, Town Historian, for her confidence in him to fill a position in the Historic Society. Last week before the meeting I asked the Board about seeing if a table of organization for the Town exists and you said you would get back to me and I haven't heard from you yet. Have you been able to look into that for me yet? Councilman Lecker said he would get back to him, he hadn't found anything yet. A couple of meetings ago I gave each Town Board member my position on our Town Charter and outsourcing Municipal jobs and at our last meeting I stated that outsourcing of Legal work was questionable. Has anyone had the opportunity to look through our Town Charter to just let me know where in the Charter that you believe we have the right to outsource any of our municipal functions that we have. I don't think we have the right. I would appreciate an answer on that soon. I also want to touch on the Arlington Fire District. The Department posted a legal notice in the district that they were going to spend \$32,000.00 for "full turnout gear". I didn't know what that meant. I thought it had something to do with some of their vehicles. They told me that this notice was to just advise that they were going to spend the money and I don't have a right to question their spending of their money is what they were trying to say on this item. Full turnout gear is gear for the fire fighters where it allows them to replace worn out equipment, which I am of course for that, I don't want them going out with only substandard equipment. But, when I asked them where this money was coming from, they were very reluctant to tell me and I'm going to pursue this matter further.

Jim Riley: I'm from the Town of Poughkeepsie Sewer Department. I regret seeing Marianne leave the Sewer Department. Also, towards the end of February, I know, on any given day, there are three vehicles from Massachusetts, one from Rhode Island, one from Connecticut, people employed by United Water down at the plant and I'm just wondering where, if anything, is going on with the negotiations and where some of our employees that I work with stand. We would like to know something.

Councilman Cifone: United Water has been asked to offer job employment to the individuals they chose to want to hire and then employees that are going to be affected, without an offer of a job, will be the ones that will be the ones offered impact negotiations. We have met twice, but until United Water actually issues the letter of hiring, we are kind of waiting on them to move forward. I believe there will be an announcement very shortly, however.

Supervisor Myers: They haven't finished negotiating the contract with the Town. I think that is what you are pretty much asking. We hired a new attorney and I don't believe he

has had a meeting with them yet. I think they are getting ready to set up meetings, but I don't think that they have yet.
