REVIEWED BY POLICE

Councilman Tancredi stated that Chief Mauro had prepared some information for the Board regarding this subject.

Police Chief Mauro: As a routine thing, the Town Clerk contacts the Police Department for review and status search of these licenses in the Town and there are approximately 40+ that are either requesting an original certificate for a license or in most cases, for a renewal. The application that was reviewed by my Department on behalf of the Town Clerk refers to the Rio Mexican Food & Eatery at 5-7 Raymond Avenue in the Town and the period for the review concerns the licensing period from April 5, 2007 to March 1, 2009. There were 44 calls for service at this address. During the period of April 1st 2009 to February 15, 2011 there were 35 calls for service at this restaurant. Some of the calls were significant and violent events and there are currently 6 pending ABC violation reports that have been forwarded to Albany concerning the restaurant. In recent weeks February 19, 2011 at 3:03 in the morning a subject was assaulted at the entrance to the bar, knocked to ground and lost consciousness and the suspect fled the scene. No cooperating witnesses and the victim refused to cooperate. February 20th at 3:04 AM, the overnight patrol shift had to be sent to the restaurant for 100+ persons standing in the middle of Raymond Avenue due to a disturbance in the street. An argument in the street subsequently led to a fight. The fight was broken up by responding patrols. The patrols were close to asking for mutual aid support, but the matter was resolved. It was all we could do to get the persons names and addresses, there were no cooperating witnesses and there were no charges that could be filed. As recent as February 27th, 2011 at 3 AM there was a disturbance inside the bar and a female received lacerations to her forehead and again our overnight patrols responded and we found out that there was a disturbance and an assault that took place inside the bar which resulted in the throwing of beer bottles, bar stools and shoes. The witness refused to cooperate with law enforcement and refused to file a complaint. The last three events and the pattern of the events in the last several years are late night events, 2 and 3 o'clock in the morning. The level of intoxication of some of these persons we had to deal with is extreme and I've done an extensive documentation of all our calls and what they are so that they can be reviewed by the Board. The position of the ABC Board is that the Police Department provides all relevant data to the Board and the Board makes a recommendation, but it is up to the ABC Board in Albany to make the final call. The local Police Agency does not recommend.

Councilman Tancredi: I try to make a practice to support the businesses in Arlington to best of my ability. I have to honestly say that in the years I've been on this Board, I've never received a report like this from the Police Department for any establishment. Never! The degree of calls that the Police have to make tot his establishment are clearly excessive and the problems with that, one of which is, the risk that the officers run in going into a situation like that. There are patrons that are there and may get caught up innocently in a case like that, but in addition to that is the cost to the taxpayers because when our Town has to spend the amount of resources we do at one establishment, if we had numerous places in the Town spending these kind of resources, we would probably need a third larger Police Department. My concern is the behavior that is going on there and that has been going on the last four years or so is certainly intolerable and I feel it just can't continue. I would like to ask the Supervisor in conjunction with the Town Attorney to make a statement to the ABC.

Supervisor Myers: I think we did this once before, not for this establishment, but another one and we sent a letter up in support of the Police Department.

Councilman Krakower: I think we want to do more than just a basic letter. I think sending the report from the Police Department with that is necessary. When you look at it, a bomb threat, larceny, fight, fight, disturbance, etc., etc., it does create a dangerous for the good people in town that are either in that establishment or in that area. When a fight spills over into the middle of the road and there are 100 people, it becomes a very dangerous situation for the officers and the people in the area. Even if we could speak directly to Albany on this because sometimes a letter just falls on a desk and remains there.

Chief Mauro: We are sending up as much documentation as we can. But, I wanted to have the packet before you first, but we are in a position that we can sent the entire investigative package to them with the whole history of the establishment. When we sent that amount of officers to an incident like we've been having there, it essentially compromises public safety to have all those police on that scene.

Entire Board echoes the same concerns and feels that it should be negatively reported to the ABC Board and they supported the Chief wholeheartedly.

Am I right on that? Oh, Beacon and East Fishkill also. We are very proud of our Police Department for having achieved

this. There were a lot of standards that had to be met and they rose to all of them and we are very pleased about that.

Victor Gennodi: “ I’ve been talking to a lot of neighbors and people in the Town and there is a lot of stuff I’m happy with and a lot I’m not happy with, but, I’m, number one, not happy about the taxes. (Inaudible) Jacobs: Owner of a business in the Town for 17 years and they always cooperated with the Police.. “ Between the poor economy and the parking situation, we almost lost all of it. Our business went down more than 50%. In order to pay the bills, we decided to have entertainment on Saturday nights. The first 9 months it went without incident and no problems at all. I do agree, lately, it has been not too good. We had made a decision to stop it completely. We stopped the entertainment and closing early. She made a comment again that the Town doesn’t want black people in it.

Supervisor Myers made sure to correct the individuals on the use of ethnic slandering.

Doreen Tignanelli: Spoke about and gave an update on the Arlington Fire Department District in the last couple of weeks.

Marianne Axtmann: Talked about the laying off of people in the Sewer Treatment Plant and privatization of it to save money and then the Board puts in the person appointed Senior Treatment Plant Operator and giving him a large salary. There were two operators up for that position and they were to be interviewed and she knows that one was not interviewed and the second thing was the promotion to Senior Operator was already decided, at least this is the impression the Sewer Department got, that that position was not needed. She expressed her feelings of the Board being “Penny wise and Pound Foolish” by paying this gentleman this high salary when two positions could have been saved with that salary. She asked, “Where is this right?”

Councilman Cifone stated that they looked at both resumes and he couldn’t get the personnel committee together to interview the two gentlemen, but they did review their resumes of them both. We know both individuals and so we just went with the resumes.

and so we chose one. We need someone to run that collection division.

Councilmen all agreed that it was not true that the salary being paid to the new recruited man would be making enough to pay two operators and the gentleman just hired was going to be making much less than Pat Brown who retired.
