

Doreen Tignanelli: So, that's not going out for bid?

Councilman Cifone: Not planning on it.

Doreen Tignanelli: Ok, so, my opinion, not just for this contract, but for any contract, the only way you can really be sure about the Town and the Taxpayers are getting the best bang for their bucks is if you solicit competition. That's my thought, so. So, it's just a straight contract with them?

Councilman Cifone: We've tightened up a few things such as services being contracted out and it's all in the contract.

Doreen Tignanelli: Ok, so it's a monthly contract for a certain amount?

Councilman Cifone: No, it's a five year contract for a specific dollar amount per month for full engineer and engineer associate.

Doreen Tignanelli: Is there any cap on this?

Councilman Krakower: The contract just covers basic services for the engineer and associate engineer.

Doreen Tignanelli: Then anything over and above you will review on an individual basis?

Councilman Krakower: Correct.

Victor Gennodi: About our Animal Warden. I'm sorry to see her leave. For many years she has done a fantastic job. I know I've called her on a number of incidents where she was very sympathetic for a stray animal and I was kind of emotional and she, a good person with a kind heart, with the animals and I hope we get someone as good and qualified as she was and as caring as she was. Even on a Sunday afternoon, she was pretty quick and there.

Councilman Tancredi: Dedicated, too.

Victor Gennodi: The new loader for the Town. The Montano Company is a good company there in Saugerties. I do business with them quite a bit. Good people and good reputation and they stand behind their equipment. They come down to do repairs and our Highway Department is going to the right place. They will bring you a machine to use if something breaks down. So, you will never be without something.

Robert Rubin: Is there any reason why the contract with Morris Associates wouldn't be bid, because on the surface it doesn't appear right to those who are not involved in it. It would appear open if there was an open bid and if there is not, there must be some justification in the file as to why the bid was the sole source as opposed to public bidding.

Councilman Cifone: For the fact that Morris has been here since I've been here and I've dealt with them on a case by case basis with every project in the Town. I know we have worked with them and saved close to ¾ million dollars just on Creek Road, Fairview and Buckingham Avenue. They are always there when I call them and I call them different hours day and night and they are very responsive. We've looked at their contract, everything when they come to us, if we don't like it, we bring it up to them and we've always been able to come to an agreement if it's excessive in cost. We hired Neil Wilson who is very experienced in project management aspect of this and he knows what they are doing and he is very happy and comfortable with them and I think most of this Board is very happy and comfortable with them. The trust factor is there. They have saved the Town residents dollars. They meet with us on week ends and on a very individual basis. We have no fault with them. You can't put a price tag on being available to the Board's needs.

Robert Rubin: I understand the trepidation that you have with going to looking for new sources. But, with my own experience, that trepidation turns out to be just a fear that we have and it hasn't been bourn out. New vendors have come in and performed well, because they know if they don't, they won't have the chance to come back.

Councilman Krakower: I've been on this Board more than 11 years now and Morris has been here before I've been here and one of the things you get with Morris is the value. Don Beer particularly, who is the Engineer for Morris and who is generally working on most of the Town's stuff. This contract effectively covers Don Beer and another engineer from Morris. There is value in having him here. He's gone from 20 hours a week to 40 hours a week for the same costs we've been previously paying. As far as I know and as long as I've been on the Board, that's the Town Engineer services have never been put out to bid, our Town Attorney hasn't, there are a lot of different positions in the Town that haven't. There are a lot of different positions in the Town that haven't regardless of what administration has been in place. When you are hiring someone for professional services, going to RFP or Bid is one way of doing it, off of going to a known source and commodity is also a way to do it. Based on all that institutional knowledge, when you ask Don Beer about the roadways, the water system, sewer system, he doesn't have to go look for some source, he is the source and there is a lot of value there and from my point of view, we are operating under an old contract where we are currently paying \$120,000 a year for 20 hours a week, so it makes sense to go ahead with this contract. We can look at other options in the future, I'm not opposed to that, but for now, we are currently getting more for less money than what we already negotiated for Morris. So, I feel we should move forward with this contract at this point in time because we are going to get 40 hours a week vs. 20 hours a week for the same money. Plus we have a vacancy when Russell King retired in February and so we have some money in the stock pile.

Robert Rubin: Time being essential, that's probably true but I would suggest, but I would suggest for the future, I would be more comfortable, seeing that if there were alternative sources being spoke with, would be proper. The reason they are not familiar with the Town is because they haven't been involved. Familiarity breeds trust.

Victor Gennodi: Voiced his agreement with the Morris Association contract.

Councilman Cifone: This is in my Ward and I contacted Tim Sickles on this and the only thing I got back from the State is that this is not in a Residential Zone, but there are still some residents over there on Beck Place and I for one, until we get more information about what kind of work they are doing, how long, what kind of machinery being used, I would be opposed to this, because the residents have put up with enough over there.

Supervisor Myers: First, the State did preservation here about this. Then after that the police, highway and, Neil met with the State about this and this is the least disruptive manner to do this in.

Councilman Cifone: Disruptive for who, though?

Supervisor Myers: The traffic. If they do it the other way, where they close half the road and put in half the underpass and then close the other half, it will be about 3 months of tying up Route 9 and one way traffic. It is actually 11 days they intend to be doing it.

Councilman Cifone: But, the residents have to sleep and go to work the next day and that is continuous 24 hours they are working there. I can't possibly approve this.

Neil Wilson, Development Director: I understand your concern. The meeting we had with DOT was specifically with the purpose of understanding exactly what the by-pass plan is and for the time frame for construction. They, the State, actually have built into the contract with the contractor incentives, \$50,000 a day for every day that they beat 11 days within that time period. So, it is significant to them in terms of being able to complete it as soon as possible. This delay would only hold up the traffic and making things worse over a longer period of time.

Councilman Cifone: I would certainly agree to let them go until 10 PM at night, but not 24 hours. Those residents are going to need their rest to go out to work the next day.

Councilman Eagleton: Is there somehow they could put up some sort of sound barriers while doing the work?

Neil Wilson: There may be. The bulk of the work is actually the excavation and the portion of it would also involve blasting within the existing State Highway right-of-way. What you are going to see in the weeks leading up to the commencement of hard construction are occasional lane shutdowns as the contractor will be doing work in some of the lanes for some periods of time to do borings and things like that to try to identify where they are able to rip rock vs. blasting rock. But, the idea is all of the excavation occurs very quickly during a very limited period of time and there is a precast tunnel. They will cut out a section of Route 9 and the tunnel goes in and then the surface gets repaved and then Route 9 is reopened. I'm not sure what techniques they may be able to use to limit sound. It's certainly going to carry some. They are going to need to light the area during the evening and night hours. I can certainly ask what noise mitigation measures they may have.

Councilman Eagleton: How close are the residents to the site?

Councilman Cifone: Real close. There are two residents on Beck Place, right next to it.

Neil Wilson: Measuring from the right of way, about 50'. I can certainly make the inquiry of DOT about putting those three families up in a motel during that time of construction.

Councilman Eagleton: There was a lot of good discussion prior to going into the agenda on both sides and obviously Morris Associates is competent and good, and I wouldn't have any hesitation to accept them in a bid process, but, I really do believe, given the magnitude of cost of this contract and the fact that it could go on for five years, despite the limits we have seemed to build into the contract, we really need to go out to bid with this. That's my opinion and I think I echo that on a number of other points as all of us have on other issues. I think it would apply here.

Supervisor Myers: On page 3, it says, in Paragraph A and then in Paragraph D depending upon whether it's the Associate Engineer or Assistant Engineer, that they shall be subject to the approval of the Director of Municipal Development. Nothing against Neil, but I think that should be the approval of the Town Board. I think it's the Town that's doing this decision making, not the Director of Development and I think we should amend it to the Town Board. My other concern is the Assistant Engineer. I'm concerned about the money for this. I think that if this person isn't starting until later this year, we probably have about \$45,000 that had been designated for a part-time person in the budget this year. But, if the salary for this Assistant Engineer is going to be \$85,000 next year, that's going to be a significant budget hit. That will be another \$40,000 that is not in this year's budget.

Councilman Krakower: As far as this year, ----

Supervisor Myers: I think it may be covered if ---if we don't appoint someone until June maybe, we should be alright for this year. But, you should realize it would be a definite increase for next year's budget.

Councilman Krakower: The money we cut out of this year's budget really was a one time cut, unless we really ---presumably we are going to have just one engineer for all services. So, yes, I think probably we would have to expect to put back in some money. As long as we have enough in the budget for this year—

Supervisor Myers: We will have to figure out exactly when this person can be hired so we don't run short for this year. I agree with you, Councilman Eagleton, things should be going to bid.
