Councilman Krakower: I have a question. Neil, 35,000 sq. ft. vs. 65,000 sq. ft., can you give me an example of a 35,000 store vs. 65,000 to get a point of reference?

Neil Wilson: 65,000 would be something closer to the Stop and Shop on Rt. 9. Roughly half of that would be down to your 35,000.

Councilman Krakower: Would it be something like the CVS on Rt. 9?

Neil Wilson: No, they are not that large. The CVS and Walgreens tends to come in around 14,000 to 15,000 now days. Half of that 35,000 is currently allowed.

Councilman Krakower: When we put the Town Centers together, the plan was to try to have more in mind with what the County Department of Planning is recommending. I think the reality of the situation is that it would be hard to build out 4, 5, or 6 Town Centers across the same Town. So, I do think that when the stats started there was the thought that some would be started and some wouldn't be as successful. I don't know how many we have at this point, but 5 or 6 Town Centers would be a little bit surprising. I agree with some of the County Planning Department points, but I do think that with what we put together like the Salt Point Center, not all of these end up working and we kind of have to make these corrections to the Code, some in theory and some in reality. My comfort level going from 35,000 to 65,000 is that this does goes back to the Planning Board and the traffic issues and the other issues that are addressed by the County Department of Planning will be addressed at the Planning Board, but I do think, at the end of the day, I'm comfortable with this. I'm not sure we've had any of the Town Centers built out the way we thought.

Neil Wilson: We have made some changes here tonight on the Salt Point Center. Of the Town Centers, when we were doing the Code amendments back in 2006 and 2007, that was when I was most dubious about because of where it was located and how it was sort of formed. If you look at the land that is available in that area, a lot of it is constrained, which is exactly why the Board took the action it did tonight to take 28 acres out because it's loaded with wetlands and drainage problems. The reality is that the bulk of the properties that are in that Town Center are single family residential lots and people living there and what it would require is a developer would have to come in and accumulate those properties. You don't have a single large piece of property that you could at least start with and then go from there. The Salt Point Center is probably one we should really rethink that, but, as we talked about in November when I first brought forward these amendments, I do think that the McDonnell Heights Center next to Crown Heights is certainly one which stands the best chance of success.

Councilman Krakower: Since this one is just starting out, before it gets too far down the road, this is another opportunity up there for sewer for the residents and there has to be some economic liability to what gets built up there so someone can afford to address that issue. I do want to try and get that sewer resolved for the people who really need it.

Supervisor Myers: It just strikes me that this whole change in this McDonnell Heights thing is being done for the developers' sake.

Neil Wilson: From the standpoint of a single owner currently having control of a certain amount of property in the current McDonnell Center ...

Supervisor Myers: Right, and we are changing the size of the retail so he can bring in a grocery store because he probably has someone who wants to put a grocery store there.

Councilman Cifone: I'm on the Plumbing Board as well and the reason this came up at the Plumbing Board, it's not so much the fine, it's the fact that the Plumbers get hit with all of their licenses at the same time if they have licenses in Putnam County, Westchester County, Kingston, and City of Poughkeepsie. So they thought, let's drop it \$100 and keep a little money in our pockets, so to speak. I did some research. The City of Poughkeepsie charges \$350 for a license renewal. They charge \$150 lay fee if it lapses. Westchester charges \$500 and Kingston charges \$200. Most of our plumbers in the Town have licenses in all these municipalities. I'm opposed to lowering the fee because it is not going to stop any additional work for the Building Department when they issue the licenses. What I would propose is making an amendment to leaving it the current rate, but allowing them to pay it through the end of January and give them a break that way so it is not due January 1<sup>st</sup>.

Supervisor Myers: I think that that is a significant change and what we would have to do in this case is to vote this down and then bring it back in January to have a new Public Hearing and have it amended the way you want it.

Town Attorney Nelson: You can vote this down and make a motion to put on for Special Consent. You have to have a Public Hearing on this before you can vote on this. If you put this on for the 4th of January, you can vote on it then and they can be ok until the end of January.
