## RESOLUTION

WHEREAS, the Wappinger Creek is one of the five major tributaries to the lower Hudson River and drains a watershed of approximately 211 square miles (134,871 acres) of land traversing 11 towns and 2 villages within Dutchess County. Originating in wetlands and lakes in the Town of Pine Plains, the watershed spans thirty eight miles and enters the Hudson River at the border of the Towns of Poughkeepsie and Wappinger, and

WHEREAS, Wappinger Creek runs through the Town of Poughkeepsie and is critical to the local economic and environmental future; and

WHEREAS, Wappinger Creek plays a central role in our local ecosystem impacting groundwater quality, biodiversity, and recreation, and

WHEREAS, the state legislature has introduced legislation in the form S.5408-A by Senator Terry Gipson and Assembly Bill A.8315 by Assemblywoman Didi Barrett that proposes to designate Wappinger Creek as an inland waterway, and

WHEREAS, this legislation would allow many communities in Dutchess County to take advantage of federal funds to protect this body of water and would increase eligibility for technical assistance under the Local Waterfront Revitalization Program (LWRP), administered by the Division of Coastal Resources under the New York Department of State, and

WHEREAS, designating the Wappinger Creek watershed as an inland waterway would make all of the aforementioned communities eligible for the grant

funding necessary for planning, design, feasibility studies, and construction projects as well as implementation of local LWRPs, and

WHEREAS, passage of this bill would allow us to apply for federal funds to invest in environmental infrastructure projects that will create jobs and improve the quality of our water; and now, therefore

BE IT RESOLVED, that the Town of Poughkeepsie requests that members of the New York State Senate and Assembly support and facilitate the ratification of Senate Bill 5408-A and Assembly Bill A.8315, and

Rob Rubin: One of the things I heard on today's meeting was SC 3 Van DeWater and Van DeWater being authorized to institute legal action for various violations at 8 IBM Road. Not that I have a problem with the representation, but what I kind of find unfathomable is that there was no maximum dollar limit set on this commitment and so what I would ask at this point if it could be considered, please, that at various points in the future, ask for periodic public reports on the dollars being spent to Van DeWater and Van DeWater if that is possible.

Councilman Krakower: That is sort of a developing situation that is being addressed by the Zoning Department and Building Department currently and we had a meeting this morning about some of the issues over there and thought it to be prudent to authorize Van DeWater to be able to start the process, if necessary, to take additional legal actions in State Supreme Court. We don't have a clear definition as to where this is going to go and that's why putting a dollar limit on the top side would be difficult, but I assure you we will watch everything closely and will be aware of where that is going and what the cost may be.

Rob Rubin: I thank you for that. My opinion is sign a blank check at this point and all I am asking for as a citizen of the Town is to have periodic public reports on any dollars appropriated.

Doreen Tignanelli: Since these Special Consent Items were not posted online, will the vehicle for hire code amendment be posted?

Councilman Carlos: Yes. We are doing some and the City is doing some and so the two Codes match.

Doreen Tignanelli: Is this Taxi's?

Councilman Carlos: Its Black Cars, Taxis and that kind of stuff.

Councilman Krakower: We started out with the same thing and I guess they tweaked theirs at some point and so we are trying to bring them back in line because it is sort of a joint enforcement between the Town and City and so we are trying to make sure ours matches up with them because it would be hard to enforce it.

Doreen Tignanelli: Ok, the only other thing is that I did see Supervisor Tancredi was on Meet the Leaders Tonight and he talked about the tax burden and how families are being forced to make tough decisions with their personal expenses and he said they may have to cut out something they really don't want to and he said that the Government needs to do the same thing and he believes that the Town has done that. But, when he was talking about the property tax bill, he also said that School Districts, Fire Districts, also need to work to control taxes and he said that all these other taxing jurisdictions need to make the same difficult decisions that the Town is making and I do agree. I believe the Town has made some tough choices when it came to the Budget and I would ask that the School District and the Fire District do the same because that has not happened, in my opinion over the years and will show up on our Town property tax bill, School taxes and Fire taxes are higher than the Town tax for the Town of Poughkeepsie. So, I ask that these other jurisdictions heed Supervisor Tancredi's request making tough choices for Town of Poughkeepsie residents.
