Councilman Baisley: Again, this is one I disagree with, the housing market being what it is and everyone is looking for apartments, I find that these projects start so many years and it takes a while to go through this, that they should have taken a closer look, I can't see how something would dip this much.

Councilman Carlos: It's a huge number. It's down three million dollars, the assessment?

Supervisor Tancredi: Yes, it's assessed at fifteen million.

Councilman Carlos: In 2013 it went from 18 to 15 and in 2014 it went from 17.1 to 14.5.

Supervisor Tancredi: These are handled by the professionals that the Town's hired to do this work; I don't have more information than that.

Councilman Baisley: I think we may see this one going back up again as the years go on because, when this was probably started, it's not a one day project. The real estate market probably wasn't what it is now where there is a need for apartments.

Supervisor Tancredi: Yes, I think one of the problems with this particular complex is that it is about 30 or 40 years old.

Councilman Baisley: The funny thing about that is you see all the retail stores, their business goes down and their assessment goes down and so basically, their assessment goes down, I don't know economics so well, but maybe they're not maintaining the buildings the way they should be and bringing in the right values and so we have to "Bite the bullet" on this.

Councilman Carlos: Basically, there is nothing we can do about this. It's a decree from a Court, so-

Supervisor Tancredi: You can fight it, but what we've discussed in the past, what happens with these re-val's is, their people and our people, our Attorneys, our

Assessor and our Appraisers get together and they give us a number and we obviously know what our number is and we give comparables and so forth and it's a negotiated settlement and in this case, if we wanted to go to court, we could, but what that would mean additional legal fees, probably additional fees for professional assessors and appraisers and we would have those fees and it would be like any court case. It's a "roll of the dice", so I think the good news is that I agree that these Tax Cert's are really a problem and it's a sign of the economy and I think from years ago, we are in very good shape in terms of our tax certs. We increased our budget line five or six years ago and for 2015 we reduced our tax cert line slightly and we are halfway through the year and quite a bit under it, even with this one and hopefully that trend will continue and these things will have leveled out.

Councilman Baisley: We are not getting as many as we used to.
