Supervisor Tancredi: We obviously heard a lot of comments from both the residents, from the company last week. I know I've been getting e-mails all week long, I've probably received 30 e-mails from the residents and a number of phone calls from people supporting the company so it's a really a difficult position for the Town Board. One of our objectives is to take the emotion out of our decision making, which is sometimes hard, and be as objective and fair as possible. What we were trying to do is to balance the interest of a local company with the interest of the residents that live in that area and it's certainly not always easy, but this is what we signed up for when we took on this responsibility.

Councilman Cifone: I know I've taken some complaints. I don't know if any of you got calls, but Sunday hours being limited were some of my concerns that some people that I've talked to wanted at least a few hours on Sunday, especially with the winter months coming. They felt that we were doing a disservice to the residents of the Town if somebody ran out of oil on a Sunday. Looking at this, we are basically cutting them out completely.

Councilman Baisley: Mike, along the line of what Todd said, we've gone over this and looked at this in and out. I've gotten numerous, numerous phone calls on this and I think this is a step in the right direction. It's a small hamlet, it's a hamlet that has a lot that goes on in it. Beside Bottini's we've got White's. There are a thousand cars a day from the train station; we have a yacht club that is very active and a very active church. And many different things going on. This is a very tight neighborhood to have to deal with and so I think this is definitely a start in the right direction right here.

Supervisor Tancredi: In terms of the hours...

Councilwoman Shershin: With that being said, I think we need to offer some hours on Sunday just for consistency throughout the Town because we've had this situation elsewhere and we did allow for some Sunday hours. So, just a small window in case if someone has an emergency and needs oil.

Councilman Conte: Just think about it for the winter months though, November 1, April 1----

Supervisor Tancredi: Our Snow Ordinance runs from November 1st to March 31st. But, my feeling is, if we're to do that, we've got to really limit those hours and make it a window where if someone needs oil, whether it's a Hospital or School or whatever, they can get in, make the delivery.

The Town Assessor, Kathleen Taber said that in the ten year period, the Town is down in the number of Certs received. We have a total of 1,466 taxable commercial properties and this year we had 23 filings out of which 16 were new. This is 1.57% of the taxable commercial parcels and in 2013, we had 35 filing of which 24 were new and at the time of the reval in 2007, there were 64 filings. We are going to buy four for \$47,000, wouldn't it be easier to just spread it out a little longer and go with the four that were purchased instead of \$37,000 for 10 of them?

Supervisor Tancredi: The problem is we are under some pressure from DEC to make sure we get some flows recorded and part of the problem is, we own 4 and we've been trying to do that with the 4 we have, but the engineers really feel we need this many to adequately test the flows and so what we are going to do is, we are pretty much done in Bill's Ward, maybe another Ward, but we're going to move into the Arlington area where there are miles of pipe and miles of flow that needs to be recorded. So this is the recommendation of the Engineering Department.

Councilman Baisley: Where is this money coming out of?

Supervisor Tancredi: The Budget and the Sewer Fund. I checked with Jim and we discussed renting them all, but again, the feeling was ---we talked about renting them-period, and not buying any-the four we purchased I think was back in 2008 and they are still working fine. They may have to be calibrated, but they are still in

good shape so Jim's recommendation was that rather than rent them, just buy them and we will have them. We only got one bid. The feeling was, these things are so expensive that the inventory this company has to keep on the shelf to let someone rent them for three months at a time....

Councilman Baisley: Is someone else doing the work or are we doing the work?

Supervisor Tancredi: We'll buy them and we'll install them. There are kinds that are cheaper, but they tend to be more problematic, so these set above the flow and things don't get caught in them as water flows through them.

Councilman Baisley: They look into the scenario of having someone else do the work? As a one shot deal and getting it all done at once?

Supervisor Tancredi: That I don't have an answer for. Not that I'm aware of. We can check on that.

Time is a little bit of an urgency on this. We need to get this work done and Engineering has been pushing on this. We can check on it, however, if you would like.
