CALL TO ORDER

SALUTE THE FLAG

Deputy Supervisor Baisley asked for a moment of silence following the pledge for the passing of Joe Myers, who worked for the Sewer Department from 1995 until his retirement in 2015.

Dep. Sup. Baisley read the Agenda.

Motion made to suspend the rules for Public Speaking on Agenda Items: Deputy Supervisor Baisley made a motion to suspend the rules for Public Speaking on agenda items, seconded by Councilman Cifone.

Marc Pfeifer, Highway Supt.: I just wanted to bring to your attention the issues of Overocker Road and tonight is to set the Public Hearing date for adding some stop signs. The first part of it is the construction going on DeGarmo Bridge and how busy the road has been and if you try to go out here at night when you are all leaving to go, there are a line of cars stacked up and it is getting kind of dangerous. I know that the police have been sitting and watching for the Rail Trail a bit and giving out some tickets and it has been helping somewhat, but unfortunately, they can't be there all the time. They don't have the manpower to keep a car there 24/7 so, the issues that we are thinking; we've gotten a lot of response from the neighbors on Overocker Road, I'm thinking that if during the construction of DeGarmo Bridge, until it is over, we can make Peckham and Overocker a three way stop. When we did the construction of the bridge in New Hamburg, we did the same thing with Reed Road and that would be a similar action of what we did there and when

the construction is over, then they can be removed. The detour from DeGarmo has you go down 44 and come over Burnett Blvd. and over this way, but everyone is cutting through Overocker because it's quicker. So, in order to slow them downbecause someone on the Rail Trail is going to get killed. There will something bad happening there and we have a few months left to go. The finish date of that is October 26th and so I think it in our best interest to do something along those lines for the stop sign. I don't know if I can get it through before the bridge is complete, but I was wondering if we could approach the State and talk to them about a "No Left Turn" from Rt. 44 to Overocker and they would be timed. It wouldn't have to be all day. The bad times are from 7 to 10 in the morning and again 3:30 to 6 at night Monday through Friday. I don't know what kind of act that takes to get through the State. I don't know if they would go with us on that or not. I know the County can't help us with that because 44 is a State Road. So, those are my two thoughts and I don't know if you can add that extra into the Public Hearing that we would be setting the date for to possibly do.

A lengthy discussion began with Board Members and several residents speaking. The Town will be asking the State to restrict left turns from Rt.44 to Overocker, and the Board will amend the Resolution to have the stop signs be placed at the Rail Trail. See the video of the meeting on YOU TUBE.

• Effective until receipt of Dutchess County D.P.W. confirmation that DeGarmo Road Bridge construction has been completed.

BE IT FURTHER RESOLVED, that, if adopted, said local law shall become effective immediately upon filing with the Secretary of State.

- 3. The Town Board refers this matter to the Dutchess County Department of Planning and Economic Development for a recommendation pursuant to GML 239-m; and
- 4. The Town Board refers this matter to the Planning Board for an advisory report pursuant to Town Code Sections 210-154.
- 5. The Town Board directs the Town Clerk to notify the clerks of the surrounding municipalities of the public hearing pursuant to GML 239-nn.
