Chapter 154. Plumbing

Article IV. Plumbers

§ 154-24. Use of license.

No holder of a license issued under this chapter shall authorize, consent to or permit the use of his, ~~or her~~ or its license by or on behalf of any other person or entity, provided however that. No person who has not qualified and obtained a license under this chapter shall hold himself or herself out to the public as licensed or as the holder of a license issued under this chapter, either directly or indirectly, by means of signs, sign cards, metal plates, stationery or in any other manner whatsoever. Except for plumbing licenses, nothing herein contained, ~~however~~, shall be construed to prohibit the use of a license by the holder thereof for or on behalf of a partnership, ~~or corporation~~, limited liability company or other for profit or not provided that 50% or more of the members of the partnership or of the officers of the corporation are licensed for profit entity if the holder of the license is an officer of such entity and the same business, trade or calling and that all work performed by such entity partnership or corporation is performed by or under the direct and continuing supervision of such license holder or holders. For plumbing licenses, nothing herein contained, however, shall be construed to prohibit the use of a license by the holder thereof for or on behalf of a partnership, corporation or other business association, provided that 51% or more of the control or voting capital stock of such partnership, corporation or other business association is owned by one or more holders of licenses for the same business trade or calling and that all work performed by such partnership, corporation or other business association is performed by or under the direct and continuing supervision of such license holder or holders. Nothing herein contained, however, shall be construed to prohibit the use of a license by the holder thereof for a not-for-profit corporation or on behalf of a publicly traded corporation or a corporation which is a subsidiary or sub-subsidiary of a publicly traded corporation, provided one or more officers of such corporation are licensed for the same business, trade or calling, and all work performed by such corporation is performed by or under the direct and continuing supervision of such license holder or holders.
