PLEASE TAKE NOTICE, that the Town Board of the Town of Poughkeepsie does hereby set the 1<sup>st</sup> day of August, 2018 as and for the date of a public hearing to be held at 7:00 p.m. at the Town Hall, Town of Poughkeepsie, One Overocker Road, Poughkeepsie, NY, to afford all interested parties an opportunity to be heard and seek public comment concerning the adoption of a Local Law amending Town of Poughkeepsie Code, Chapter 195, entitled "Vehicle and Traffic", specifically §§ 195-36 Schedule I, 195-44 Schedule IX, and 195-47 Schedule XII to remove the traffic control signals at Seitz Terrace and VanWagner Road, to add four stop signs: Seitz Terrace South at Springside Avenue (All Way, LED blinker), VanWagner Road North at Seitz Terrace (All Way), VanWagner Road South at Seitz Terrace (All Way), and Springside Avenue East at Van Wagner Road (All Way), and to add a crosswalk on VanWagner Road just West of its intersection with Arlington Avenue.

BE IT RESOLVED, that the Town Board of the Town of Poughkeepsie, does hereby set the 1st day of August, 2018 at 7:00 PM, at the Town Hall, Town of Poughkeepsie, One Overocker Road, Poughkeepsie, NY, as and for the time, date, and place of a public hearing to consider local law amendments to Town Code Chapter 195, entitled "Vehicle and Traffic", specifically §§ 195-36 Schedule I, 195-44 Schedule IX, and 195-47 Schedule XII to remove the traffic control signals at Seitz Terrace and VanWagner Road, to add four stop signs (Seitz Terrace South at Springside Avenue (All Way, LED blinker), VanWagner Road North at Seitz Terrace (All Way), VanWagner Road South at Seitz Terrace (All Way), and Springside Avenue East at Van Wagner Road (All Way), and to add a crosswalk on VanWagner Road just West of its intersection with Arlington Avenue, all as detailed on Exhibit A annexed hereto with the language to be added underscored and the language to be deleted ~~stricken~~, which Exhibit is incorporated herein by reference as if it were read verbatim; and

BE IT RESOLVED that said amendments, if adopted, will take effect immediately upon filing with the Secretary of State.
