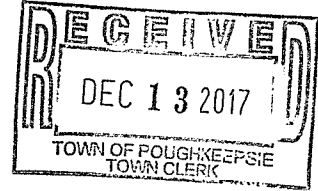

CERTIFICATE OF RESULT OF CANVASS

The undersigned, ANNEMARIE BECKER, Chairperson of the Election; KRIS RENIHAN; Inspector of Election; and, TRICIA PEREZ; Ballot Clerk, DO HEREBY CERTIFY AS FOLLOWS;

That each of us is a resident tax payer of the NEW HAMBURG FIRE DISTRICT, in the Town of Poughkeepsie, Dutchess County, New York; that pursuant to a resolution adopted by the Board of Fire Commissioners of said Fire District on 30<sup>th</sup> day of November, 2017, we were appointed to the offices set forth hereinabove for the annual election of said Fire District held on the 12<sup>th</sup> day of December, 2017, between the hours of 6:00 o'clock p.m. and 9:00 o'clock p.m. Eastern Standard Time for the purpose of electing one Fire Commissioner for a full term of five (5) years, and one Fire Commissioner for a term of one (1) year commencing January 1, 2018.
