

All voters registered with the Dutchess County Board of Elections on or before November 22, 2010 shall be eligible to vote.

Candidates for Fire Commissioner for the five year term shall have filed their petitions, with the Secretary of the Arlington Fire District, at the firehouse at 11 Burnett Boulevard, no later than twenty days before the election, November 24, 2010 and it must be subscribed by at least twenty-five (25) qualified voters of the Arlington Fire District.
