Kirkbride Plan? What? (Who?)

Thomas Story Kirkbride (1809 - 1883,) an American psychologist and founding member of the Association of Medical Superintendents of American Institutions for the Insane (AMSAII)—forerunner of the American Psychiatric Association and superintendent of the Pennsylvania Hospital for the Insane is regarded as one of the most prominent authorities on mental health care in the latter half of the nineteenth century. In his 1854 work, *On the Construction, Organization, and General Arrangements of Hospitals for the Insane* Dr. Kirkbride describes his ideal asylum. The typical floor plan, with **long wings arranged in a staggered fashion** so that each connected wing **received sunlight and fresh air**, was meant to promote **privacy and comfort** for patients. The building form itself was meant to have a curative effect, and adhere to the **philosophy of Moral Treatment.**

Hudson River State Hospital

After approval by the New York State Legislature in 1866 **Frederick Clarke Withers** began the design for a large psychiatric facility in the **High Victorian Gothic** style, the first use of that style for an American institutional building. **Calvert Vaux and Frederick Law Olmsted**, of Central Park, Manhattan, NYC fame, designed the sprawling grounds. Construction began in 1868 and upon the admission of its first 40 patients in **1871**, was considered the most modern facility yet built in New York State. After **132 years** of service to the citizens of New York State, Hudson River State Hospital was shuttered in 2003; in 2007 the south (male) wing was struck by lightning and sustained considerable damage.

President's Message

I would like to speak about the importance and uniqueness of the Hudson River State Hospital site. Not only was it unique in that it was one of only a handful of High Victorian Kirkbride plan hospitals, but it was also unique in the way it defied the kirkbride model. It was an asymmetrical structure, with many window and door variations. The building featured many one of a kind hand crafted ornamental pieces throughout. Even in its ruined state, the craftsmanship in the construction of the hospital is visible. Brickwork, stonework and metalwork were all incredibly crafted and spared no expense to provide a beautiful home for the mentally ill. Historically, and architecturally, this is an irreplaceable jewel of architecture and humanity.

Although we as an organization understand the economic importance of the redevelopment of the Hudson River site, it is equally important to proceed cautiously. To proceed in a way that there is recognition and solemn respect for what this place meant for so many who lived and died here. The respect for families who entrusted this site with their loved ones. We will never see buildings built like this, built to serve humanity. That in and of itself makes Hudson River State Hospital a unique structure. -Christian VanAntwerpen
