Note: For Bill Pay check users, Banks and Credit Unions mail tax payments from processing centers. The envelopes lack U.S. postmarks due to banks having either presorted first class or bulk mail permits. Please mail early; however, there is no guarantee the tax office will receive payment by the due date.

If the tax office receives payment after the original due date, by law, penalties are assessed.
