



**RESOLUTION 10:20 - #SC<sup>2</sup> of 2021**

WHEREAS, the Town Board has determined, for reasons of economy and efficiency, and as suggested by the Town Clerk, to repeal the current Town Code Chapter 105 “Fees” and replace it with a new Chapter 105 and a fee schedule adopted and amended from time to time by Town Board resolution, and to further amend the Town Code so that all other Code references to specific fees and charges will refer to the Fee Schedule as adopted and amended from time to time by Town Board resolution, and

WHEREAS, it is proposed that the current Chapter 105 be repealed in its entirety and replaced with a new Chapter 105 as annexed hereto at Exhibit A, and incorporated herein at length as if it had been recited verbatim, and

WHEREAS, the adoption of a Local Law to repeal and replace Chapter 105 requires a public hearing,

NOW, THEREFORE BE IT RESOLVED THAT:

1. The Town Board hereby sets a public hearing on the proposed repeal and replacement of Chapter 105, and amending the other Town Code references to fees and charges for November 3, 2021, at 7:00 PM, or as soon thereafter as the matter may come to be heard at the Town Hall, One Overocker Road, Poughkeepsie, New York; and
2. Because the adoption of the proposed Local Law does not involve an Action under SEQR which might impact the environment, and because it is part of the ongoing administration of Town affairs with no new programs or priorities, it is a Type II Action requiring no environmental review; and
3. The Town Board directs that the Town Clerk notify the clerks of the surrounding municipalities of the public hearing pursuant to GML 239-nn.

# EXHIBIT A

**Chapter 105 Fees in its entirety is repealed and replaced with the following:**

## Chapter 105. Fees

### § 105-1. Purpose.

The purpose of this chapter is to provide for a consolidated schedule of fees to be charged in the administration of Town laws, ordinances, regulations and resolutions and to permit the -review and modification of such fees by Town Board resolution from time to time.

### § 105-2. Applicability.

Effective January 1, 2022 all Town fees and charges previously listed in the prior Chapter 105, and those listed elsewhere in the Town Code, are reflected in a Fee Schedule maintained in the Office of the Town Clerk and other Town Departments, which fees may be amended from time to time by resolution of the Town Board, and further provided that all fee provisions appearing in the Code other than prior Chapter 105 shall be amended to reflect their location in the Fee Schedule

### § 105-3. Effective Date.

This Local Law shall take effect on January 1, 2022 after filing with the Department of State.
