§ 154-24. Use of license.

[Amended 1-21-2004 by L.L. No. 1-2004; 9-22-2004 by L.L. No. 18-2004; 3-14-2018 by L.L. No. 4-2018]

No holder of a license issued under this chapter shall authorize, consent to or permit the use of his, her or its license by or on behalf of any other person or entity; provided, however, that nothing herein contained shall be construed to prohibit the use of a license by the holder thereof for or on behalf of one other partnership, corporation, limited liability company or other for-profit or not-for-profit entity ("Entity") if the holder of the license is an officer of such eEntity and all work performed by such eEntity is performed by or under the direct and continuing supervision of such license holder or holders, or for a second Entity if the holder is an officer of it, has a 51% ownership interest in it, and all work is performed by or under the direct and continuing supervision of such license holder or holders.
