Supervisor Myers: Why are we changing?

Councilman Krakower: The only thing left with Rose & Kiernan, Inc. is this, I believe. William A. Smith took over our other insurance and they saved us a couple of hundred thousand dollars and to me it doesn't make sense to leave this one piece with the previous insurance company, so it would be basically moving all the Workman's Compensation over to the William A. Smith where everything else is.

Supervisor Myers: So we are not saving any money by moving this, it's just to consolidate?

Councilman Tancredi: Right now, yes.

Supervisor Myers: I would kind of like to leave it with the other broker so we are sort of spreading the wealth, such as it is.

Councilman Krakower: As far as spreading the wealth, the other broker had our business and didn't do anything to save us money and they had our business 5 or 6 years and Mr. Smith's company came in and saved us a couple of hundred thousand dollars doing something, which, in my opinion, the other broker should have done and so as far as spreading the wealth, that's great. We were overpaying for a couple of years, essentially.

Supervisor Myers: But, Workman's Comp is really cut and dry.

Councilman Cifone: Rose and Kiernan never answered any of our questions and they didn't save us any money and really didn't look out for us and save us money.

Unidentified Speaker: When you change insurance brokers and you don't change carriers, each of the carriers has a certain time line by which they will recognize such a change and last year I was asked to looked at the lines other than Workman's Compensation and suggested to the Council people that at the time Perma was probably the current carrier is probably best place to stay and with the savings we generated, that we also change brokers. Unfortunately, it was too late in the game at that point in time. So, as a consequence most of this year, we've kind of had on and off conversations about considering doing that this year and I have already talked to Comptroller Woitowicz about looking at some of the payroll areas as there are some changes being made within the Town's structures with some of the things you are doing. There may be areas were there could be savings now rather than waiting until your audit which is done after your next policy period is over. I do think there are opportunities to look at your experience modification and the loses that are used in that to make sure Perma has closed them on a timely basis and that you are not being penalized for open loses that are possibly closed and should have been considered. Next year it would be my intent to look at other markets to see if there is a better place for the Workman's Comp. However, every year is different within the insurance market. I have the best interest of the Town at heart here, also, as I am a resident of the Town and am looking to save taxes and my kids go to school here and so I'm looking out for my interests as well. It's vitally important to me to help the Town reduce its costs.
