# 7:00 PM CALL TO ORDER SALUTE THE FLAG

Motion made to suspend the rules for public speaking on Public Hearing: Supervisor Myers/S. Eagleton

Allyson Phillips, Attorney with law firm Young Sommer, LLC and I'm here representing several property owners who own property within the Crown Heights Center Overlay District and some other parcels within the Spackenkill School District and we are here to communicate some of the concerns we have about the proposed amendments and the process by which the Board has come to consider these proposed amendments. I have some written comments that I would like to submit to the Board (She handed them out to the Board).

Jeff Cane: I'm a Director for Developer of TC Development, which is the managing agent for the properties represented by Allyson Phillips of Young Sommer, LLC.

Allyson Phillips: I would just like to start by talking about the purpose of Zoning and the reason why we have Zoning for the protection of the health, welfare and safety of the entire community. In NY State, the way the law ensures that is that the Town legislatures do act in furthering these interests in adopting Zoning is requiring the Zoning to be in conformance with a comprehensive plan for development. We have a comprehensive plan for development in the Town of Poughkeepsie, which was adopted by the Town in 2007, and from what I understand, it was a very thorough process and a lot of contemplation went into that preparation of that document.

At the same time, Zoning Amendments were adopted, which created the Overlay District. Our concerns now are that these amendments are substantial amendments to those Zoning regulations which were adopted in 2007 and from our perspective, the process, up until this point, has not really been transplanted. There has not been a lot of public outreach or public input when these proposed amendments were being developed. Our client has only been aware of these amendments within the last two weeks and so we went back and looked at the minutes and tried to look at how the Town has been considering these amendments and really saw a lack of public discussion in the Town's minutes about these amendments and what conditions have changed in the Town since 2007 that would provide a basis and support for adopting these amendments. The only discussion we saw in the minutes were back in February of 2009 at which time a resolution was made to authorize the Town's Department of Planning to prepare a supplemental GEIS that would examine the potential impact to the Zoning Amendments. During that discussion in those meetings, it was stated that a draft of those amendments were stated to the Board and had been discussed with a developer who owns property in the Zoning District on the east side of the road as part of a settlement negotiations. I don't know at this point if that has been settled, but from the statements made in the minutes, we can only believe that these proposed amendments have been initiated and probably drafted with a settlement in mind. If the amendments were calculated to benefit only one developer or intended to act as a give and take between the Town and the developer so the Town can receive something for exchange for passing Zoning amendments, then we take the position outside of the Town Board's (inaudible) when they adopted the zoning. I don't know if that's the case, but we can only go on the limited discussion we see in the Town Board minutes. It obviously raises concerns for us because we feel the process hasn't been transparent up to this point. I don't know if the Board has given any real consideration of the environmental impacts that would result, not only from the amendments of this rezoning law, but what kind of development these amendments would actually submit. The real issue is, what is going to be permitted by the Zoning Amendments. That is a concern for us and we feel the Town Board should take a hard look at. Up to this point, it doesn't appear that the Town has done that at all.

Councilman Krakower: As far as not having the information readily available, a lot of this has been discussed for years. Your client has been a part of a lot of that discussion. Your client has reached out to us a number of times in the past regarding issues and we've always been available to sit down and talk to any property owner about issues. You said you've just been brought into it and am not sure about many issues and I think that's clear. There is a long history with this property and Zoning and Overlay District and your client, again, has been a part of a lot of that discussion. This thing was on our Board agenda and referred to the Planning Board, discussed at the Planning Board Meeting fairly recently and so this didn't really sneek up on anybody.

Jeff Cane: You're right, Councilman Krakower, you have discussed potential Zoning changes with us over the years. The specific language we are talking about really is new to us.

Councilman Krakower: Almost all of this has been discussed with you and your client at some point in the past and so I don't think there is too much here you are seeing for the first time.

Jeff Cane: There are some unattended consequences we see in the language that is specifically in this draft and that is why we raised some of the issues in the written comments that was distributed to the Board. Those are the items we think needs some comments.

Councilman Krakower: I think the Board appreciates the input, but it was just kind of the insinuation that this thing was done quietly and without information available to people, that was not the case at all. We have a website with agendas on it and that information is out there and available.

Jeff Cane: This language wasn't and that was the issue.

Allyson Phillips continued stating that there was still considerable information that she was not able to find or locate. She felt that this is a process that everyone in the Town should be made aware of how important these amendments are and how it will affect the Town.

David Kaminski: I am the managing member of the several properties that have been mentioned and the client to which my attorney just spoke. I had to come up here given some of the comments that have been made. We have had an incredibly good relationship in the developments that we have done in the Spackenkill School District with this Town over a twenty year period, but, I feel left out. We represent almost 10% of the taxes that are made in the Spackenkill School District. I have never had discussed with me a Conference Center Hotel. I have never had decisive projects being geared to by development so that, in fact, if a property owner wants to sub-divide a parcel, like you have on the east side, you may not end up with just 400,000 sq. feet of development, because it is by project now, you could end up with 800,000 sq. ft. or you could have a million .2. That's what this amendment says. It has never been discussed with us. I could go on and on. We have a dozen issues that I have never ever had anyone mention to me is in this. We think this needs to be discussed. We are asking you to keep the Public Hearing Open. We have written you a letter with all of our concerns. It is our fault we got involved with this late, you are right. We always knew, to solve a problem this Town needs to be solved, and we know what that is, that there were going to be additional residential units approved and something had to be done to make this thing go away. We didn't understand there would be all these changes and we didn't understand, as this now provides, if I wanted to buy some property on either the east or west side, I can build a Wal-Mart right next to the Residential District you are trying to protect, because of the language you've done here, yes, it's in here, but it's a mistake. It needs to be done and done properly with all the adjoining property owners that are all we are asking for.

Councilman Krakower: That's what we are doing here, it's a Public Hearing.

David Kaminski: Ok, then I want to make it clear here, we are opposed to this. All five of the properties I represent in Spackenkill are opposed to this and if it is passed, I will file an Article 78 filing and instead of having one lawsuit, you may have multiple lawsuits. So, it doesn't make sense.

Doreen Tignanelli: I had no intention of speaking on this subject tonight, but I have to say, this is just amazing to me. During the Master Plan process, there were people who thought that there

were meetings with developers maybe behind the scenes that members of the public were not privy to, we felt that there was not the transparency. We felt that some developers were maybe being favored over the needs of the Town in general. Whether that was true or not, I'm not sure, but the point is, at the time, I can speak for myself, I thought that Mr. Kaminski may have been one of those people who was benefiting, but now it seems like that maybe because there is no real benefit to Mr. Kaminski in this one and maybe it's Ginsberg he is concerned about, now there is a concern. People brought up issues of segmentation when it came to the Spackenkill Project and Oakwood Commons those were Mr. Kaminski's. Well, segmentation wasn't an issue then, but guess what, now it sounds like segmentation is an issue. Environmental impacts, we had concerns about environmental impacts and not just polluting, traffic, etc. Let's take just traffic, well Mr. Kaminski's Neptune Center that he is just submitted an application for, there is a question on the EAF and it says, "Will your project need any additional community services?" Police, Fire, School." He answered "No." Well it's very unlikely that Police or Fire services aren't going to be necessary. How many times have we heard about traffic studies? No matter how many projects are up and down Route 9 or any place else there is never any traffic impacts to these projects. Nobody every looks at these cumulative impacts, they say "Our specific project, we're not the person or project that is going to push the traffic over the edge here." So, it seems like that now that this particular amendment might not be to benefit Mr. Kaminski, he has an issue, well maybe now he knows how the rest of us felt as he was developing up and down Route 9 and we felt that things were, whether or not they were, but we that's how we felt and I feel it's a bit disingenuous to get up here and say there is no transparency. There are things on the website, there are meetings and if you don't come, they are televised and replayed, you can watch them. This is just a case of sour grapes.

Councilman Krakower: I will say, I take all calls and Mr. Kaminski's calls and e-mails everyone else's and so I think this Board is always open to discussing these matters.

**Composting Facility** 

Duffy Layton, Duffy Layton Contracting, Inc.: I've been in business about 25 years. I started out as a partner in an excavating company for ten years and bought him out about 15 years ago. Approximately 10 years ago I started composting. We currently work out of Stanfordville, New York. We have 2 one acre composting pads that we work on. One is blacktop and one is recyclable asphalt. (An extremely detailed and pictured booklet of his presentation is on file).

Councilman Tancredi: I'm not sure, but if we are able to use that site, or you are trying to discourage us from working with you or not.

Duffy Layton: I'm interested in working with you, absolutely, however, my concern is that we all work on a safe site so there isn't a liability.

Councilman Tancredi: Well, obviously, we do want to have a safe site, we don't want to put our residents in harms way, but in these economic times, spending \$100,000. I understand you have a great operation and I'm sure the money we paid you was well worth it. But, you can understand the Boards investigating---

Fairview Avenue Delays/Increased Costs

Don Beer: I came to discuss the status of the stimulus jobs that are currently in progress. You may know, there are three of them. They are currently being worked on at the moment. Sheafe Road is the first one, work is almost complete on this one, and it has been paved. Coloruso is the contractor and they appear to be in budget at the moment. We expect them to finish in budget. Hudson Valley Engineering Associates, which had a budget of \$130,000 appears to be within their budget. That project was a 60 day project, but, there was less time in the field than originally anticipated, so there should be a savings on the Engineering Budget there. Fairview Avenue began on April 27<sup>th</sup> and was supposed to be completed in 60 days. If everything had gone according to plan, we believe the contractor could have made the schedule, but everything is not going according to plan. We've hit fiber optics, we've hit water lines with less cover than was anticipated. We've hit foundations on basins. I say we've hit, the contractors hit these.

Councilman Eagleton: You found them or hit them?

Don Beer: Well, both. We haven't caused any major utility concerns, let's put it that way. After looking at the schedule, we should have had a little bit longer time frame. We knew this was the older section of Town and there were more utilities. The contractor has now asked for a six week time extension. It was a 60 day job and now he is looking for another 42 days and we don't believe he needs all 6 weeks and we will not be recommending a 6 week time extension. We feel they are doing an adequate job as far as far as the work, but they really haven't had more than one crew in place at any one point in time. Morris Associates sent them letters about the schedule on 5/17, 6/2, 6/14 and 6/15 and also had job meetings with them. The last request made on 6/15 finally generated the request from the contractor for an extension, that's how we found out that they were looking for another six weeks.

Councilman Cifone: Do you think they could do it in four?

Don Beer: I would think that to be the right recommendation, yes. The extension really doesn't cause us any problems in the field, the job is moving along. Most of the drainage is in but will have to have Morris inspect and document similar to what they do now and that cost is running about \$10,000 a week.

Councilman Tancredi: And that's mandated by the Federal Government that's being done?

Don Beer: That's correct. It's required for full time record keeping. It's costing about 20 hours a day right now, which it is a little less than what was happening with Sheafe and will be happening in Creek, but it still, obviously, a significant expense. Right now, Morris is about 9 weeks in. They had a budget of \$85,000 and most of that has been expended, not all, but most. The reason is because most of the job has been working, it's just that they haven't been progressing as fast as I believe they should have. I do believe they should get some time extension. We would have probable saved \$45,000 if we could have stayed within the 60 day budget. It's still cheaper than what we would have spent on Sheafe Road had that been a 60 day budget, but, it is still going to cost us \$10,000 a week.

Councilman Tancredi: Can we approach the contractor? Why should we be stuck with this full tab because they want an extension?

Don Beer: Well, I believe the contractor is justified to have some extension. They have not documented properly yet, what extension, they asked for 6 weeks, but they haven't documented it yet.

Councilman Tancredi: You said they have had unforeseen issues. You also said they had one crew at a time working. Does our contract with them specify how much equipment or how much manpower they are to have on the job any given week or whatever?

Don Beer: No. The methods and means of a contractor are strictly within his care.

Councilman Krakower: Can we give them a short leash at this point and give them two weeks and then they can come back if the need more?

Don Beer: I don't think two weeks is going to cut it because they haven't even touched any of the manholes. They haven't finished the drainage because they had to order some basins to be made. We believe it will be at least a two week paving process. They have reclamation and paving to do on the far end of the street. That's going to be at least a week. From Cedar to Fulton they have to reclaim and pave. Maybe they can get that done within a week. Maybe we don't have to go to four weeks, but at some point it's a question of litigation over the extras and extra time vs. what they are going to have to pay.

Councilman Krakower: I would keep them on as short of a leash as possible. If we have to revisit it, then fine.

Supervisor Myers: Would three weeks work?

Don Beer: I could certainly go back to three weeks. The only thing I could tell him that if he can't maintain more than one crew out there for some of this work, then we don't want to see them working that day. If he maintained two crews out there and then didn't work the next day, we then wouldn't have to have Morris on site that day. Creek Road has also been awarded to Wiltsie. That was supposed to start before the College was done for Spring, but Wiltsie said they would start it immediately after. Hudson Valley Engineering is the Inspector on this one and their position is that Wiltsie is waiting until they are done on Fairview before they start Creek. There is obviously some time in the beginning of these jobs, you have to order materials, catch basins have to be fabricated and materials delivered to the site. So, I've asked Hudson Valley Engineering Associates once again, to document this delay, so in any event we end up in the exact position that we are with Fairview, at least we have it documented so we can determine what to do at that point, but, means and methods are up to the contractor. Technically, until we can get a schedule from them and we can comment on the schedule and say "No way is your schedule anyway good, change it", but in 55 days, we have not gotten any schedule from the contractor. At this rate, it won't be done before college is back in session.

Supervisor Myers: Motivate them!

Town Attorney Hagstrom: Would it make it a little more motivated if the Board said, "Please report on July 7<sup>th</sup> as to where things are"? That's two weeks from now and our regular Board Meeting.

Don Beer: Sure.

Councilman Krakower: So, we are not going to give them any extension right now?

Don Beer: No. If we don't give them an extension, they will run out on the 25<sup>th</sup> of June.

Supervisor Myers: I think we have to give them the minimum, give them three weeks and that will give them to the 7<sup>th</sup> of July.
