- B. Effective Billing August 13, 2018, all water shall be billed at the rate of \$2.50 per 100 cubic feet.

RESOLUTION 6:20- # 6 OF 2018**

BE IT RESOLVED, that the Town Board of the Town of Poughkeepsie does hereby set the 11th day of July, 2018 at 7:00 p.m. at the Town Hall, Town of Poughkeepsie, One Overocker Road, Poughkeepsie, NY as and for the time, date and place of a public hearing to consider amendments by local law to the Town Code, Chapter 203 Water, Article 1, Town-wide Water Improvement Area, § 203-8, Rates, Charges and Billing, subsections A& B, as follows, with the language to be added underscored and the language to be deleted stricken:

- A. Effective August 13, 2018 the minimum rent per quarter, which includes rental of meter, if any, shall be ~~\$7-~~\$18.75.
- B. Effective billing ~~January 1, 1983~~ August 13, 2018, all water shall be billed at the rate of ~~\$1.50-~~\$2.50 per 100 cubic feet.

AND BE IT FURTHER RESOLVED, that the aforesaid action is a type II Action requiring no SEQRA review; and

BE IT FURTHER RESOLVED, that said amendments, if adopted, will take effect immediately upon filing with the Secretary of State.
