**NOTICE OF SPECIAL MEETING**

PLEASE TAKE NOTICE that the Board of Fire Commissioners of the Fairview Fire District will convene via telephone conference call to conduct a Special Board meeting at 6:00 PM on December 15th, 2020. The Meeting will be held in accordance with the New York State Public Officers Law, as modified or suspended by Executive Order 202.1, issued on March 12, 2020 by New York State Governor Andrew Cuomo, which has been continued by EO 202.78. EO 202.1 suspended Article 7 of the Public Officers Law, to the extent necessary to allow any public body to meet and conduct its public business without allowing the public to attend such meeting in person, and further authorized such meeting to be held remotely by telephone conference call or similar service, provided that the public has the ability to view or listen to such proceeding and that such meetings are recorded and later transcribed.

In view of the on-going public health emergency and the restrictions on in-person meetings and gatherings ordered by Executive Orders 202.4, issued on March 16, 2020; EO 202.10, issued on March 23, 2020; and EO 202.74, issued on November 12, 2020, the Board anticipates the meeting will be conducted by telephone conference call. While there will not be a physical meeting location, for the purpose of compliance with applicable law as to the location of meetings, the meeting shall be deemed to be convened at the Fairview Firehouse, 258 Violet Avenue, Poughkeepsie. It is anticipated that the Commissioners and staff will attend and participate in the Meeting by telephone conference call. Interested members of the public may listen to the meeting by calling the dial-in number below. The Chairman will allow public comment during the portion of the agenda designated for public comment.
