**EXTENSION AND AMENDMENT AGREEMENT**

THIS AGREEMENT, bearing the date set forth on the signature page, by and between the **COUNTY OF DUTCHESS**, a municipal corporation with offices at 22 Market Street, Poughkeepsie, New York 12601 (hereinafter referred to as the “COUNTY”), and **TOWN OF POUGHKEEPSIE**, a municipal corporation whose address is 1 Overocker Road, Poughkeepsie, New York 12603 (hereinafter referred to as the “MUNICIPALITY”).

***WITNESSETH:***

WHEREAS, the parties hereto made and entered into an agreement dated June 15, 2017 (County Contract No. 17-0201-12/17-PT), for the Municipality to provide contributory funding to the County for the Dial-A-Ride public transportation system, which agreement has been extended and/or amended from time to time, and

WHEREAS, the parties desire to further extend and amend said agreement upon the terms and conditions hereinafter set forth, now, therefore, it is mutually agreed by and between the parties hereto that County Contract No. 17-0201-12/17-PT, dated June 15, 2017, is hereby further extended and amended upon the following terms and conditions.

1. Paragraph entitled “Term of Agreement,” shall provide as follows:

This Agreement shall be effective January 1, 2021 and shall terminate on December 31, 2021, unless otherwise terminated as set forth herein.

2. Paragraph entitled “Payment,” shall provide as follows:

The Municipality will pay to the County, pursuant to a signed voucher submitted to the Municipality, payments according to the payment/service schedule attached hereto, made a part hereof and marked Exhibit “B-4”. Payments by the Municipality will not exceed \$68,540.00 during the term of this agreement.

3. New paragraph entitled “Counterparts; Signatures Transmitted By Electronic Means,” shall provide as follows:

This Agreement may be executed in any number of counterparts, all of which taken together shall constitute one agreement, and any of the parties hereto may execute this Agreement by signing any such counterpart. A facsimile or signature transmitted by electronic means applied hereto or to any other document shall have the same force and effect as a manually signed original. This provision contemplates giving legal force and effect to copies of signatures. This provision does not contemplate the use of “electronic signatures” as regulated by New York State Technology Law Article 3, “Electronic Signatures and Records Act.”

4. All other terms and conditions of the underlying agreement, and any amendment thereto not expressly amended or altered by this agreement, shall remain in full force and effect.

**RESOLUTION 2:03 - # 8 OF 2021**

*WHEREAS*, the Town of Poughkeepsie contracted with Cablevision of Wappingers Falls, Inc., now d/b/a Altice, USA (“Altice”), by Franchise Renewal Agreement (“Agreement”), effective May 16, 2005, to provide cable service for ten years in the Town of Poughkeepsie; and

*WHEREAS*, Troy and Banks Consultants, LLC, performed an audit of the services provided and the payments made to the Town pursuant to the Agreement, and found that Altice had failed to pay \$96,858 to the Town pursuant to the Agreement, which sum Altice has, despite demands therefor, refused and failed to pay to the Town; now, therefore
